

Forward P/E Ratio is a bottom-up calculation based on the most recent S&P 500 Index price, divided by consensus estimates for earnings in the next 12 months (NTM), and is provided by FactSet Market Aggregates. Trailing P/E ratios are bottom-up values defined as month-end price divided by the last 12 months of available reported earnings. Historical data can change as new information becomes available. Note that P/E ratios for the S&P 500 may differ from estimates elsewhere in this book due to the use of a bottom-up calculation of constituent earnings (as described) rather than a top-down calculation. This methodology is used to allow proper comparison of sector level data to broad index level data. Dividend yields are bottom-up values defined as the annualized value of the most recent cash dividend as a percent of month-end price. Beta calculations are based on 10 years of monthly price returns for the S&P 500 and its sub-indices. Beta's are calculated on a monthly frequency over the past 10-years. Past performance is not indicative of future returns.









% of days during bull markets the S&P 500 is at and near record highs






























Net Job Creation Since Feb. 2010 – Millions of Jobs











Net imports of liquid fuels as a percent of total US consumption











Billions of dollars






















Europe: Cyclical Headwinds and Tailwinds

Europe: Unemployment, Inflation and Credit Markets















Estimated increase in real GDP growth from a 1% increase in DM growth




MSCI EM Country Index by Sector

China: Economic and Credit Growth









20-year Annualized Returns by Asset Class (1994 – 2013)






